

CHRISTIANA ANNUAL MEETING 2007

Meeting called to order at 7:00 p.m. April 10th, 2007 Stanley Lien made motion to appoint Dennis Lund Chairman of meeting second Mike Cutrano motion carried 9 voice ayes. There were 10 residences in attendance with 2 more coming later.

Bob Salov made motion to approve 2006 annual meeting minutes second Lee Powers motion carried 10 voice ayes.

Dennis Lund made motion to table financial report second Virginia Kravik (auditor did not have it finished) motion carried 11 voice ayes.

Road Work Proposed-level wedge and overlay Koshkonong between Evergreen Drive and Highway 73-spot wedging on Hillcrest, Rodney, Evergreen, Koshkonong (west of Hwy W), and Washington (overlays cost approximately \$75,000.00 per mile. Gravel Roads town has 7 miles-add 4 inches of gravel to all roads would cost approximately \$40,000.00 for just the gravel. Bridge & Culvert Work-small culvert on Tobacco Road-no major culvert repairs foreseen-some ditching and small culverts as needed.

Stanley Lien made motion for resolution authorizing Town Board to obtain a loan not to exceed \$100,000.00 if needed in 2007 second Lee Powers motion carried 12 voice ayes.

Motion by Janice Redford to table payment to East Koshkonong Cemetery Association (clerk will check into cost of America Flags for graves) second Stanley Lien motion carried 12 voice ayes.

Stanley made motion to bank funds at Cambridge State Bank second Mike Cutrano discussion amended by Janice Redford that town board invest funds where town can get best return on money second Mike Cutrano motion carried on 12 voice ayes.

Motion by Lee Powers to set next years Annual Meeting to second Tuesday of April-April 8, 2008 Statuary Date second Stanley Lien motion carried 12 voice ayes.

Town Open Book will be Monday, April 23, 2007-5 to 7:00 p.m. and Town Board of Review will be Monday, May 14, 2007-5:00 p.m. to adjournment.

Dennis Lund made motion to adjourn meeting to 7:00 p.m. on May 8, 2007 to go over Town's 2006 Financial Statement and Payment to East Koshkonong Cemetery Association Fund second Virginia Kravik motion carried 12 voice ayes.

Adjourned annual meeting was called to order on May 8th, 2007 at 7:00 by Dennis Lund-7 residents were in attendance. First item tabled from April 10th meeting was East Koshkonong Cemetery Association Fund for flags for veteran's graves-Clerk Nancy talked to former Commander and Chief of the Veterans organization who stated that the organization has not taken any money from East Koshkonong Church Cemetery Association for flags and that the \$106.00 town received from the State Veteran's Association would cover cost of flags. Dennis Lund made a motion to pay \$250.00 to Koshkonong Cemetery Association at board's discursion second Virginia Kravik motion carried 6 voice ayes.

Peter Nagel Clifton Gunderson presented 2006 Financial Statement and answered any questions residents had motion by Ken Stach to approve 2006 Financial Statement as presented second Virginia Kravik motion carried 6 voice ayes.

Motion by Dennis Lund to adjourn second Kravik motion carried 7 voice ayes meeting adjourned.
