

**TOWN OF CHRISTIANA  
MONTHLY BOARD MEETING  
January 12, 2010**

Meeting called to order by Chairman Rattmann at 7:00 p.m. others present included supervisors Kravik and Cutrano, clerk treasurer Brattlie, Mike Lange from Veolia and other local residents. Meeting was legally posted at town hall, Utica Store and Cambridge State Bank.

Cutrano made motion to approve minutes of December 8<sup>th</sup> meeting second Kravik motion carried 3 ayes.

Motion by Kravik to approve treasurer's report checks 12867 thru 12919 second Rattmann motion carried 3 ayes.

Rattmann made motion to change agenda to go to Veolia Contract items second Kravik motion carried 3 ayes.

Mike Lange Operations Manager from Veolia explained to Town Board the Service Addendums for solid waste and recycling services for the town are the same as last year except he stated that recycling will be picked up every other week and Veolia will provide each resident with a 95 gallon roll out cart for recycling which will start in March-a resident can purchase additional cart for \$15.00 if they would like. Veolia will be sending out mail out with schedule of recycling pick up.

Rattmann made a motion to approve Service Addendums Veolia second Cutrano motion carried 3 ayes.

Motion by Rattmann to approve ordinance 44, chapter 10 creating a PUD "Plan Unit Development" which provides for a different and streamlined system to review land use proposals second Cutrano motion carried 3 ayes.

Cutrano made motion to approve ordinance 45, chapter 10 Transfer of Development Rights (TDR)-transfer of splits from one parcel to another second Kravik motion carried 3 ayes.

Motion by Cutrano to approve ordinance 46, chapter 10 Sign Regulations "copy area" second Kravik motion carried 3 ayes.

Cutrano made motion to change ordinance number 2009-1 to 2010-1 to adopt the Town of Christiana Comprehensive plan pursuant to sections 62.23(2) and (3) of the Wisconsin Statutes, as defined in sections 66.1001(1)(a) and 66.1001(2) second Kravik, roll call Kravik aye, Cutrano aye, Rattmann aye motion carried 3 ayes.

Motion by Kravik to change Christiana resolution number 2009-2 to 2010-1 requesting Dane County Adopt the Town of Christiana Comprehensive Plan pursuant to section 66.1001(4) Wisconsin Statutes second Cutrano motion carried 3 ayes.

The Town Board decided to close out bank deposit box at Cambridge State Bank and bring maps etc to safe at town hall.

Motion by Rattmann to pay bills second Kravik motion carried 3 ayes.

Kravik made motion to adjourn at 7:32 p.m. second Cutrano motion carried 3 ayes.
