

**Town of Christiana  
Regular Board Meeting  
November 13, 2007**

Meeting called to order by chairman Lund at 7:00 p.m. others present included supervisors Kravik and Cutrano, town lawyer Bousea, petitioner Cutrano and other local residents.

Meeting was legally posted.

Kravik made motion to approve minutes of October 9, 2007 meeting second Cutrano motion carried 3 ayes. Motion by Lund to approve minutes of October 23 special meeting second Kravik motion carried 3 ayes.

Motion by Lund to approve treasurer's report checks 11688 thru 11726 second Kravik motion carried 3 ayes.

Deputy John Nelson from Dane County Sheriff's who is in charge of Town of Christiana and surrounding area was introduced-he stated that there have been a lot of rural robberies. Pleasant Springs has been hit hard with robberies the last year and is having an information meeting on November 15 to start a neighborhood watch.

Lund made motion to approve ordinance/petition no. 9724 for Michael Cutrano deed restrictions required for C-2 second Kravik motion carried 3 ayes, 1 abstaining.

Motion by Lund to table approval of planner for comprehensive/smart growth plan second Cutrano motion carried 3 ayes.

Motion by Lund to appoint Virginia Kravik, Cindy Cutrano, Megan Wisersky, Nolan Johnson, Tom Jelinek, Duane Hinchley and Dennis Lund to Smart Growth Committee second Kravik motion carried 3 ayes.

Lund made motion to adopt resolution regarding the American Transmission Company placement of the 345 KV power line-the town board recommends new power line be placed on the proposed "Northern Route" and is in opposition to the placement of the power line on the proposed "southern line" second Kravik motion carried 3 ayes.

Lund made motion to extend town land rent contract for town land for an additional 1 year for James Johnson at current rate for 2008 crop year-bids will go out in August 2008 for following year 2009 second Cutrano motion carried 3 ayes.

Motion by Cutrano to approve operator's license for Shelia Sugden-Utica Bar second Kravik motion carried 3 ayes.

Town action taken on budget items-

1. Lund made motion to increase McFarland Outreach contribution from \$2,000.00 to 2,500.00 second Kravik motion carried 3 ayes.
2. Motion by Lund to increase patrolmen's wages 55cents an hour second Kravik motion carried 3 ayes.
3. Lund made motion to increase clerk's salary 3% for year 2008 second Cutrano motion carried 3 ayes.

Kravik made motion to pay bills second Cutrano motion carried 3 ayes.

Motion by Lund to adjourn second Kravik motion carried 3 ayes.
